LEGAL GOVERNANCE STRUCTURE

GENERAL ASSEMBLY

Highest governing body of the legal entity, in accordance with the bylaws.



BOARD OF DIRECTORS

Provides institutional direction and adopts the decisions assigned to it.

INSTITUTIONAL MANAGEMENT AND COORDINATION

Leads management, coordinates institutional areas, and implements authorized decisions.



TEAMS, PROJECT LEADS, AND OPERATIONAL AREAS

Carry out activities, manage processes, and report results in accordance with their functions.

GENERAL FUNCTIONS

Body or level	Summary public function
General Assembly	It is the highest governing body of the Foundation and performs the functions established in the bylaws and applicable law.
Board of Directors	Provides institutional direction, adopts decisions within its authority, and oversees management.
Legal Representation	Legally represents the Foundation, formalizes authorized acts and agreements, and is accountable to authorities, partners, and third parties within the scope of the role.
Institutional management and coordination	Leads day-to-day management, coordinates teams and areas, supports programme implementation, and ensures that institutional decisions are applied.
Teams and operational areas	Implement projects, research, training, cooperation, communication, and territorial work according to their assigned responsibilities.

INSTITUTIONAL DISTINCTIONS

Legal governance	Architecture of the Kingdom
It belongs to the General Assembly, Board of Directors, legal representation, and the bodies authorized by the bylaws. These structures are responsible for legal, financial, and contractual decisions.	The Crown, the micronation, the Model, and the institutions of the ecosystem express the identity, mission, methodology, and capacities of Kingdom of the Pearl, but do not replace the Foundation's legal governing bodies.

PUBLICATION AND PROTECTION STANDARD

- The website will identify the governing bodies, their functions, and the legal representative.
- The names of the members of the General Assembly and Board of Directors will not be published in this public version.
- Full documentation may be provided upon a legitimate due diligence request and through secure channels.
- Identity documents, signatures, private addresses, personal telephone numbers, and minutes containing sensitive information will not be published.
